Inactive Account Alert:

The state of PA's escheat law requires all financial institutions to forward to the Department of Revenue any funds in an account that has had no activity in the past 3 years.

The Credit Union wants to make sure your account stays active and your funds on deposit stay with you. If your account has had "no activity" for a period of 18 months, your account will incur a \$5.00 inactive fee per month.

After 36 months of dormancy, your account will be escheated to the state.

If you receive a notice in the mail, please reactivate your account ASAP by doing one of the following types of transactions or simply return the signed notice to the Credit Union.

You can either deposit, withdrawal or transfer to reactivate your account.
